## Notice Without Prejudice Served Electronically

We have received complaints and irrefutable evidence from multiple sources against your RWA and its president, a D P Kaushik, about cruelty against the community dogs resident in your society since several years. All these dogs were neutered, vaccinated, well socialized. They were looked after by compassionate residents at their own private cost, effort and time. Reportedly, your society has a cruel and sadistic history of crimes against animals including killing of puppies. Per reports, complaints and evidence with us from several sources, on the intervening night of 23.09.2024 / 24.09.2024 a "meeting of residents" was called late at night in the open grounds of the society to discuss an alleged "dog bite" case ---- there has historically never been any objective or admissible evidence of dog bites and in this case too there was no evidence – just a malicious, premeditated allegation. Sticks had been brought into your society prior – same size and girth (per

photographic evidence) and stocked prior to this “meeting”. Reportedly D P Kaushik had also summoned drunken goons in three cars and two dogs were mercilessly killed while the others were mortally injured. Bodies of the killed dogs were hidden/sought to be destroyed --- a penal offence under the Bhartiya Nagrik Suraksha Sanhita 2023. There are detailed narratives in writing from several separate residents and the bodies have been found. The above is the broad contextual outline. The barbaric, premeditated crime is unacceptable and we are committed to ensuring prosecution under law of the perpetrators. You, as an office bearer of the RWA is informed of these multiple cognizable offences committed individually and jointly/severally under:

### 1. Prevention of Cruelty to Animals Act

### 2. The Bhartiya Nyaya Sanhita – BNS Section 325 {Crimes against animals}

### 3. Bhartiya Nyaya Sanhita – BNS Section 238 {Causing Disappearance of Evidence}

### 4. Bhartiya Nyaya Sanhita – BNS Section 3 (5) {Common Intention}

### 5. Bhartiya Nyaya Sanhita – BNS Section 61 {Criminal Conspiracy}

### 6. Contempt of the Hon’ble Supreme Court of India and the Hon’ble Punjab & Haryana High Court.

- **The Hon’ble Punjab & Haryana High Court at Chandigarh CRR 533-2013**

**Date of decision 31.05.2019 {Karnail Singh & Ors Vs State of Haryana}**

Excerpts: “Page 90 of 104 We have established that there is nothing inherent in the concept of legal personality preventing its extension to animals...Para 29, Page 104 of 104 : The entire animal kingdom including avian and aquatic are declared as legal entities having a distinct persona with corresponding rights, duties and liabilities of a living person. All the citizens throughout the State of Haryana are hereby declared persons in loco parentis as the human face for the welfare / protection of animals.”

265025) Vide SLP (C) y 691/2009 and

subsequent final order ref Civil Appeal 5988 of 2019 of May 09, 2024 of the Hon'ble Supreme Court of India :

“...that under all circumstances, there cannot be any indiscriminate killings of canines and the authorities have to take action in terms of the mandate and spirit of the prevalent legislation(s) in place. There is no gainsaying in the fact that exhibiting compassion to all living beings, is the enshrined Constitutional value and mandate, and cast obligation on the authorities to maintain.”

You are informed and warned of the legal consequences of these actions.

You are required to :

1. File a police complaint with your local police station against the perpetrators led by D P Kaushik, the delinquent security guards and comprising residents who are identified with incriminating evidence in our possession. Share the same with the undersigned by Saturday, October 5<sup>th</sup> 2024.

2. Rehabilitate/return the missing dogs and ensure that the two remaining dogs are unharmed at all points in time --- this direct and indirect responsibility lies with the RWA of which you are a functionary.

3. ENSURE that no further crimes against animals take place at any point in time.

Failure to do so will invite punitive action against office bearers of the RWA and others in question. You are further informed that **this notice is without prejudice to the rights and contentions of other/all the animal lovers/activists to take appropriate action against in the appropriate court/courts of law and you/offenders will personally be liable for cost and consequences there upon.**
